The company is unable to fulfil the specification of the obstetrical delivery table.

- No power Hi/Lo, till, leg section backrest functions (no manual neither electronic)
- · Height of table is not adjustable.
- Not retractable so approach to the patient difficult.

Medequips (Pvt) Ltd. Is the only single bidder for the tender of delivery table. So kindly retender.

## ULTRASOUND MACHINE

- The quoted model in portable ultrasound machine, in specification we need built in trolley mounted machine.
- Trackball and keyboard are seperate from ultrasound it should be built in with ultrasound machine.
- No sales reference, even in private and government sector and no after sale service record.
- No company balance sheet, audit reports, engineering staff etc. found in technical bid.

Sial Traders was asked about Demonstration but they failed to come for this. Under the clause on bidding document of page 18 clause 7.1 not providing Demo so they have been disqualified.

- Imported storage boxes for optics not available.

- Picture enhancement to 3D or 4K and or upgradation of system not available.
- Image details, picture in picture, image capturing not as per specifications.
- Monitor is not medical grade & not from the principal.
- Light source working hours not mentioned.
- Recording system capacity not specified
- CO2 cylinder 240CFT not provided.

## PAEDS LAPAROSCOPE WITH HD CAMERA SYSTEM

Please find attached the technical report regarding Pediatric Laparoscopy instruments.

1. M/S Allmed Solutions:

The quoted specifications of instruments meet our demands.

M/S Verizon:

Following deficiencies have been noted in their quotation.

- 3.5mm bipolar forceps does not meet our demand. We have demanded dissecting and rotating 3.5 mm bipolar forceps.
- Knot-pusher is not according to our requirement.
- · Suction irrigation unit doesn't have pistol grip handle.
- LCD monitor has been quoted. Our demand is LED 32-inch monitor.
- Pyloric knife has not been quoted.

If the bidder can rectify these problems, then they can be accepted.

#### 3. M/S Vertex medical:

Following deficiencies have been noted in their quotation.

- CMOS Camera system has been guoted, whereas our demand was 3CCd camera system.
- · 3.5 mm dissecting and rotating bipolar forceps has not been quoted.
- Knot-pusher is not according to our demand.
- Suction irrigation unit doesn't have pistol grip handle.
- Laparoscopic Pyloric knife does not meet our requirements.
- Our previous laparoscopic set was bought form the same manufacturer and their after sale support was very poor. The quality of provided instruments was not good resulting in early wear of costly instruments.

The bidder does not meet out demand so may be rejected.

## 4. M/S Endoaid Biomedical:

Following deficiencies were noted in their quotation.

- CMOS camera system has been quoted, whereas our demand is 3CCD camera system.
- · Four 5mm trocar cannula were demanded but they have quoted only one.
- 3.5mm instruments were demanded but they have quoted 3mm instrument.
- Knot-pusher is not according to our demand.
- · Suction irrigation unit has not been quoted.
- Laparoscopic Pyloric knife is being provided through local supply.
- Xenon light source has been quoted whereas we have demanded LED light source.

The bidder does not meet our demand so may be rejected.

## 3 Mediland Pakistan (Pvt) Ltd - quoted following items:

Light Source Integrated light source with processor EPK i5000

As per brochure, available on internet the quoted video processor EPK-i5000 does not have HD-SDI port, hence do not meet the advertised specifications. The representatives of Mediland Pakistan (Pvt) Ltd were called for clarification but they failed to satisfy the end users.

Same specifications were advertised in 2017 and at that time, Mediland quoted video processor EPK-i7000 (superior to the current quotation and matched the specifications).

The models of their accessories (forceps, electrocautry probe, TBNA needle) are also not specified in the bid. Similarly, the models of APC probes also not mentioned in the bid.

The technical committee should exclude them in the tender process.

## PLASMA STORAGE FREEZER BLOOD BALK

Please find attached the technical report regarding plasma storage freezer of Blood Bank.

Detailed requirement was stainless steel interior, interior, Automatic defrost (hot gas), automatic closing of the doors, controlled fan cooling, operated power switch per day, safety door lock.

Additional requirements were interior doors to minimize loss of refrigeration, integrated RS-485/USB interface, and 220 V 550 Hz AC.

User adjustable settings required were temperature range down to -40-degree C, and gross volume of 8 cu ft. or more.

Net capacity required is minimum 120 plasma bags of 450ml each. For this we also require, 200-250 minutes hold over time at +25 ambient temperatures. The displayed parameters were digital temperature display, acoustical and visual alarm for temperature and power failure, alarm system with battery backup, and door opening alarm.

Accessories required were, servo controlled voltage stabilizer with surge protection facility, operating manual with soft copy, and service manual with soft copy.
